3.01 DIVISION INTO WARDS AND PRECINCTS. The City is divided into three (3) wards and four (4) precincts.

3.02 JOINT CITY – DELAWARE COUNTY PRECINCT NUMBER 13. Delaware County Precinct Number 13 is described as follows:

North Fork Township and that part of Bremen Township lying south of 210th Street and that part of said Bremen Township lying south of 197th Street and west of 300th Avenue and the territory contained within the property described as beginning at the center of Section 25, Township 89 North, Range 3 West of the 5th P.M., thence south to the southwest corner of the Southwest Quarter of the Southeast Quarter of Section 36, Township 89 North, Range 3 West of the 5th P.M., thence east to the southeast corner of Section 36, Township 89 North, Range 2 West of the 5th P.M., thence north to the northeast corner of the Northeast Quarter of the Southeast Quarter of Section 25, Township 89 North, Range 3 West of the 5th P.M., thence west to the point of beginning.

3.03 WARD 1.

WARD 1

Beginning at the center of Section 25, Township 89 North, Range 3 West of the 5th P.M., thence south to the southwest corner of the Southwest Quarter of the Southeast Quarter of Section 36, Township 89 North, Range 3 West of the 5th P.M., thence east to the southeast corner of Section 36, Township 89 North, Range 2 West of the 5th P.M., thence north to the northeast corner of the Northeast Quarter of the Southeast Quarter of Section 25, Township 89 North, Range 3 West of the 5th P.M., thence west to the point of beginning, and

WARD 1 – PRECINCT NUMBER 2

Beginning at the southwest corner of Section 31, Township 89 North, Range 2 West of the 5th P.M., thence east to the centerline of the North Fork of the Maquoketa River, thence north along the centerline of the North Fork of the Maquoketa River to the centerline of First Avenue West, thence west along the centerline of First Avenue West to the centerline of Fourth Street Northwest, thence north along the centerline of Fourth Street Northwest to the centerline of the Illinois Central Gulf Railroad Track, thence west along the centerline of the Illinois Central Gulf Railroad Track to the centerline of Fifth Street Northwest, thence north along the centerline of Fifth Street Northwest to the centerline of Sixth Avenue Northwest, thence east along the centerline of Sixth Avenue Northwest, to the centerline of Second Street Northwest, thence north along the

centerline of Second Street Northwest to the centerline of Eighth Avenue Northwest, thence east along the centerline of Eighth Avenue Northwest, to the centerline of Second Street Northeast, thence north along the centerline of Second Street Northeast, to its intersection with the North Corporate boundary of the City of Dyersville, Iowa, thence west along the North Corporate Boundary of the City of Dyersville, Iowa, to the northeast corner of the Northeast Quarter of the Southeast Quarter of Section 25, Township 89 North, Range 3 West of the 5th P.M., thence south to the point of beginning.

3.04 WARD 2.

WARD 2 – PRECINCT NUMBER 3

Beginning at the intersection of Second Street Northeast with the North Corporate Boundary of the City of Dyersville, Iowa, thence east along the North Corporate Boundary of the City of Dyersville, Iowa, to the northeast corner of Lot 8 of Valley Oaks Subdivision in the City of Dyersville, Iowa, thence south along the East Corporate limit of the City of Dyersville, Iowa, to its intersection with the centerline of the Illinois Central Gulf Railroad Track, thence northwesterly along the centerline of the Illinois Central Gulf Railroad Track to its intersection with Iowa State Highway #136, thence southwesterly along the centerline of Iowa State Highway #136 to its intersection with the centerline of Second Avenue Southeast, thence northerly along the centerline of Second Avenue Southeast, to the centerline of Ninth Street Southeast, thence south along the centerline of Ninth Street Southeast to the centerline of Fourth Avenue Southeast, thence west along the centerline of Fourth Avenue Southeast, to the centerline of Eighth Street Southeast, thence south along the centerline of Eighth Street Southeast, to the centerline of Fifth Avenue Southeast, thence west along the centerline of Fifth Avenue Southeast, to the centerline of the North Fork of the Maquoketa River, thence northerly along the centerline of the North Fork of the Maquoketa River to its intersection with the centerline of First Avenue West, thence west along the centerline of First Avenue West to the centerline of Fourth Street Northwest, thence north along the centerline of Fourth Street Northwest to the centerline of the Illinois Central Gulf Railroad Track, thence west along the Illinois Central Gulf Railroad Track to the centerline of Fifth Street Northwest, thence north along the centerline Fifth Street Northwest, to the centerline of Sixth Avenue Northwest, thence east along the centerline of Sixth Avenue Northwest to the centerline of Second Street Northwest, thence north along the centerline of Second Street Northwest, to the centerline of Eighth Avenue Northwest, thence east along the centerline of Eighth Avenue Northwest, to the centerline of Second Street Northeast, thence north along the centerline of Second Street Northeast to the point of beginning.

3.05 WARD 3.

WARD 3 – PRECINCT NUMBER 4

The Third Ward shall comprise and include all that part of the City of Dyersville, Iowa, not included within the First and Second Wards as above described.
